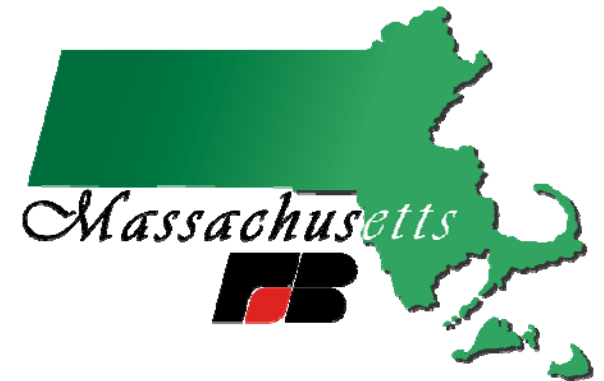
What is the Farm Bureau
